

*MicroPatent* offers full-text patent searching of US, European, Patent Cooperation Treaty (WO), French, Great Britain, and German patent records as well as the front page of Japanese patent documents. Search one or more of the databases, read patent documents, and download PDF images of patent documents.

**MacIntosh Users:** This site works best with Safari, Netscape, or any browser other than Internet Explorer.

**First time users must complete the EZ-Login process.**

### Micropatent EZ-Login process

Visit the Micropatent login web site <http://www.micropat.com/cgi-bin/easylogin> and complete the following steps.

1. Enter your PNNL email address in the box provided and click **Submit**.
2. An email message with a 4-digit confirmation code and link to the Micropatent login site is sent to you within 5 minutes.
3. Go to the login link in the message, enter your e-mail address, and click **Logon to MicroPatent**. You will be prompted to enter the emailed 4-digit confirmation code.
4. Future logins require you to enter your e-mail address and then you will go directly into the system.

### How do I download a PDF copy of a patent if I already know the patent number?

1. After logging in, click the **Order Patents and File Histories** link at the top of the Micropatent home page.
2. In the **ORDER PATENT COPIES** text box, type the patent number(s) you want to download. Enter one patent number per line. The patent number must include the country code <http://www.micropat.com/countrycode.html> as a prefix with no spaces between the country code and patent number. **Examples: US6629040, WO2002054287, EP1265269**
3. Click the **Patent Copies** button to the right of the text box to place your order.
4. The MicroPatent® Document Availability and Pricing screen lists the patent(s) you requested, pages, and frequently the title. **Download PDF Format - Complete Documents** is the default format from the **Delivery Options** drop down menu. You may choose another option if you prefer. Click the **Submit Order** button.
5. It may take a few seconds to several minutes to prepare your order for download. Click the **Click Here for Current Order Status** button. When the documents are ready, the button will be replaced by one or more links.
6. Right click a link and choose **Save Target as** (IE) or **Save Link as** (Netscape) to download the PDF document or zip file to your computer.
7. Open and read individual patent files with the Acrobat Reader or unzip zip files before opening with the Acrobat Reader.

**Costs:** Most patents are available at no charge; however patents from the Exceptional Documents Collection incur a fee. The amount will be listed on the download screen before you submit your order. **You will be contacted to provide a work package by library staff when we receive the monthly MicroPatent bill.** Detailed information about document costs is available at [http://www.micropat.com/0/new\\_patentdoc9809.html](http://www.micropat.com/0/new_patentdoc9809.html).

### How do I look for patents by Inventor or Assignee?

1. Log in and select **Full Text Searching: PatSearch® FullText**.
2. Use the checkboxes to select the databases you want to search.
3. Select a date range in the **Years to Search** drop down menu.
4. Choose a field from the **Limit by** drop down menu. You may search multiple fields simultaneously.

**Note:** US patents published before 1971 have limited field searching options. All fields except patent number, publication date, and US Class Codes, are indexed as part of the text. Search for inventors, assignees, and claims by selecting **Full Patent Spec.** in the **Sections to Search** drop down menu and entering terms in the **Search Text for box**.

5. Enter key terms in the search box and click **Search**.

## How do I search for patent documents by keyword?

1. After logging in, select **Full Text Searching: PatSearch® FullText**.
2. Use the checkboxes to select the databases you want to search.
3. Select a date range in the **Years to Search** drop down menu.
4. Choose search fields using the **Selections to Search** drop down menu. You may search all fields by choosing **Full Patent Spec.** for a broad search. Select **Title or Abstract** or **Claims, Title or Abstract** for a more focused search.
5. Enter keywords in the **Search Text for** box and click **Search**.

### Search Tips

- *Inventor Names:* Names are indexed both as individual words and as phrases. Begin with the last name.
  - MicroPatent recommends using the bound phrase method for inventor searches. This requires using an underscore between words. **Examples: Graff\_Gordon\_L** or **Graff\_G\***
  - You may also use the adjacency operator. **Example: Graff ADJ Gordon**
  - Search names as a phrase using quotations marks. **Example: "Graff Gordon"**
- *Search Operators:* MicroPatent supports Boolean operators, adjacency searching, and mathematical value searching. If you do not specify an operator, AND is the default. A complete list of search operators and examples is available at [http://www.micropat.com/mp\\_help\\_desk/psft\\_help/search\\_operators.htm](http://www.micropat.com/mp_help_desk/psft_help/search_operators.htm).
- *Wildcards:* Wildcards can be used at the beginning, in the middle, or the end of a word.
  - Use the asterisk (\*) to substitute for none or many characters. **Example: semiconductor\*** retrieves semiconductor, semiconductors, semiconducting, etc.
  - Use the question mark (?) to substitute for only one character. **Example: sterili?e** retrieves sterilize or sterilise
- *Phrase Searching:* Enclose one or more terms in quotations marks (" ") to search for them together as a phrase. **Example: "solid oxide fuel cell"**
- *Hyphenated Terms:* Hyphens are treated as a space. Search for hyphenated terms using the adjacency operator or as a phrase. **Example: fiber ADJ optic** or **"fiber optic"**

## How do I view and order patent documents that I find during a search?

- The first 50 records retrieved by your search are displayed after you click the **Search** button. Use the navigation buttons at the top and bottom of the screen to look at additional pages of results.
- Results are displayed in an unsorted list, but three sort options are provided in the drop down box next to the **GO** button. You may sort by issue date, primary international class (IPC), or by Assignee/Applicant. Make a selection and click **GO**.
- Click the check box next to the patent number to select relevant patent documents.
  - Use the **Order/Download** button to pre-fill the **ORDER PATENT COPIES** form and download PDF copies of the patent documents. Follow the instructions on this sheet under **How do I download a PDF copy of a patent if I already know the patent number?** to complete the process.
  - **Find Similar** will generate a new query using words extracted from the records you selected. You may select fields from the Find Similar search form. The query may take several minutes to complete.
- Click the patent or application number button to open the full-text HTML document.
  - **Family Lookup** displays equivalent patents and patent applications for the same invention submitted in multiple countries.

## How do I set up an alert to receive email notification about new patents in my field?

1. Click **Full Text Searching: PatSearch® FullText** from the MicroPatent home page.
2. Conduct a search for the alert topic you want to create.
3. Click the **Search** icon at the top or bottom of your search results to return to the search page.
4. Open **Search History** by clicking the link at the top of the search page.
5. In the **Action** column of the Search History table, click **Alert**.
6. Complete the Alert Form selecting your preferred delivery options.
7. Click the **Submit** button at the bottom of the form to initiate the alert.
